

2019 AMENDMENT TO
ASSISTANT SUPERINTENDENT AND BUSINESS MANAGER
CONTRACT OF EMPLOYMENT

THIS AMENDMENT, made and entered into this 28th day of January, 2019, by and between the BOARD OF EDUCATION OF CANTON UNION SCHOOL DISTRICT NO. 66, FULTON COUNTY, ILLINOIS (hereinafter referred to as the "Board"), and TAD DERENZY, an individual, (hereinafter referred to as the "Administrator").

WITNESSETH:

WHEREAS, the Administrator previously entered into a performance-based, multi-year Assistant Superintendent and Business Manager Contract of Employment with the Board on August 20, 2018, for a period of three (3) years, commencing July 1, 2018, and ending June 30, 2021 (herein the "Contract"); and

WHEREAS, the Board and the Administrator desire to modify the Contract as set forth in this Amendment; and

WHEREAS, the Board and the Administrator agree that this Amendment does not extend the Contract pursuant to 105 ILCS 5/10-23.8a; and

WHEREAS, the Board at a special meeting held on the 28th day of January, 2019, by motion duly made, seconded and carried by majority per a roll call vote, has authorized the execution of this Amendment to the Contract with TAD DERENZY; and

WHEREAS, TAD DERENZY is willing to enter into and execute this Amendment to the Contract.

NOW, THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt of which is hereby acknowledged, it is agreed between the parties as follows:

A. Salary. Paragraph 5 of the Contract currently provides that the Administrator shall receive an annual salary of \$100,000 for the 2018-2019 contract year. The Board and Administrator hereby modify the terms of Paragraph 5 by agreeing that, for the 2018-2019 contract year only, the Administrator's salary shall be increased to \$115,000 to compensate for additional duties temporarily assigned in this contract year. The Board and Administrator agree that the salary amounts stated in the Contract for other years shall remain unchanged.

B. Unused Vacation. Paragraph 12 of the Contract currently provides that unused vacation days will convert to sick days at the end of the contract year in which they were earned, except upon separation of employment. The Board and Administrator hereby modify the terms of Paragraph 12 by agreeing that, for the 2018-2019 contract year only, the Administrator's unused vacation days shall be paid to the Administrator at his current per diem rate, which will

be calculated by dividing \$115,000 by 260 days. The Board and Administrator agree that the conversion to sick days as provided in the Contract for other years shall remain unchanged.

C. No Extension of Contract. The parties agree that this Amendment is not an extension of the term of the Contract pursuant to the provisions of Section 10-23.8a of the School Code, and does not alter Paragraph 2 of the Contract.

D. All Other Terms. The parties agree that all other terms contained in the Contract that do not conflict with the terms stated above shall remain unchanged.

This Amendment may be executed in one or more counterparts, each of which shall be considered an original, and all of which taken together shall be considered one and the same instrument.


